

**THIS AGREEMENT** dated the \_\_\_\_ day of \_\_\_\_\_, 200\_\_\_\_, between **IE SPORTS**, with offices located at P.O. Box 2402 Washington, DC 20013-2402., hereinafter referred to as “**IE Sports**”, and \_\_\_\_\_, with an address of \_\_\_\_\_, hereinafter referred to as “**Sponsor**” Whereas, IE Sports is in the business of setting up and operating sports leagues for various sports for recreational purposes; and **Whereas, Sponsor** desires to form a sports team for participation in a sport team league run by **IE Sports**.

**W I T N E S S E T H:**

That for and in consideration of the mutual covenants and promises exchanged herein from one party to another and for other valuable consideration set forth herein, the parties do herewith agree as follows:

**SPONSOR’S RESPONSIBILITIES**

1. **Sponsor** agrees to form a Basketball team with persons who desire to play Basketball as a team to be sponsored by **Sponsor**.

2. **Sponsor** agrees to supply **IE Sports** with a list comprising the name, address and telephone number of all members of **Sponsor’s** team who will play basketball, and **Sponsor** further agrees, from time-to-time, should there be a substitution of members upon its team, to promptly notify **IE Sports** of the name, address, and telephone number of such substitute person.

3. **Sponsor** agrees that it or each member of its team will supply all first-aid equipment and other equipment which **Sponsor** deems necessary for the operation of its basketball team.

4. **Sponsor** agrees that **Sponsor** and its team shall comply with and be bound by all of the rules of the basketball league run by IE Sports, which rules are attached hereto, and which, from time-to-time, may, at the sole discretion of IE Sports, be amended.

5. **Sponsor** agrees that all disputes with respect to all basketball games in which **Sponsor’s** team plays, shall be decided by the referees supplied by **IE Sports** and that said referees decision shall be final.

6. **Sponsor** and members of its team agree and acknowledge that **IE Sports** shall not be responsible for any injury suffered by **Sponsor** or any member of **Sponsor’s** team as a result of any cause whatsoever, to include the playing of basketball games or the traveling to and from basketball games, or at any other time or under any circumstance whatsoever, and **Sponsor** and members of **Sponsor’s** team do hereby specifically release **IE Sports** from any responsibilities or damages which **Sponsor** or any member of its team may suffer from any cause whatsoever.

7. **Sponsor** agrees that upon notification from **IE Sports** as to the time, place, and date of each game the **Sponsor’s** team will play, that **Sponsor** will cause its team to be at such place at such time and date promptly so that the basketball game may commence. **Sponsor** further recognizes and acknowledges that if **Sponsor’s** team fails to appear at a scheduled game, that **Sponsor** will have forfeited said game to the opposing team against which **Sponsor** was to play on said date.

8. **Sponsor** agrees that it will supply all coaches and captains for its team.

9. **Sponsor** agrees that it will, upon the execution of this Agreement, pay to **IE Sports** the invoiced amount for said team in the league as a fee to **IE Sports** and in payment of **IE Sports’** services to **Sponsor** in accordance with this Agreement. If **Sponsor** does not pay the aforementioned fee before said period on invoice, the **Sponsor** agrees to pay a collection fee of no more than 25% of the total amount due on top of the original amount on said invoice.

**IE SPORTS’ RESPONSIBILITIES**

10. **IE Sports** agrees to coordinate **Sponsor’s** team and all other teams in the league in which **Sponsor’s** team shall play basketball.

11. **IE Sports** agrees that it will compile the scores of each game, the standings of the teams, including **Sponsor’s** team in the league, and shall provide **Sponsor** with a weekly newsletter called “**SportsNews**” which shall be sent to **Sponsor**.

12. **IE Sports** shall notify **Sponsor** as to the date, time, and place that each game shall take place in which **Sponsor’s** team shall play, and in the event of inclement weather, **IE Sports** shall notify **Sponsor** of the alternate date for any game that cannot be played because of inclement weather.

13. **IE Sports** agrees to arrange for **Sponsor’s** team to play in at least eight (8) games during said period, together with any playoffs and championship games should **Sponsor’s** team be eligible for same.

14. **Sponsor** agrees that at the conclusion of the aforementioned time period, the obligations of IE Sports pursuant to this Agreement, shall be terminated and IE Sports shall have no further obligation to **Sponsor**.

15. For each game which **Sponsor’s** team plays, **IE Sports**, at its cost, shall supply all necessary equipment, which at the conclusion of each game, shall be returned to **IE Sports** by delivering same to the

referees.

16. **IE Sports** shall supply, at its costs, two (2) game coordinators for each game, and **IE Sports** shall schedule the games at its sole discretion and shall provide the gym for each game at its discretion.

17. At the conclusion of the league's season of any playoff and championship games, **IE Sports** shall notify **Sponsor** of the winning team to be declared by **IE Sports** to have won the league championship. **IE Sports** shall supply the **Sponsor** of the winning championship team with a trophy designating the winning **Sponsor's** team as the champion of the league.

18. **Sponsor** and **IE Sports** agrees that **IE Sports** shall have no other responsibility to **Sponsor** or members of its team, other than as specifically designated herein.

19. Attached hereto are regulations governing the operation of the league in which **Sponsor's** team shall play and by which **Sponsor** agrees to be bound.
